I hereby enter into this Future Care Program Agreement with Friends of Cats, Inc., a non-profit organization (thereafter FOC) for the future care of my cat(s).

- 1. I hereby grant FOC permission to enter my residence to remove my cat(s) pursuant to the terms of this agreement. I understand that FOC will make every effort to pick up my cat(s) within 24 hours after receiving notification of my need for this service.
- 2. I authorize FOC to spay or neuter any of my cats not already sterilized, and which is to be performed by FOC's veterinarian.
- 3. If my cat(s) are located outside the county of San Diego, I authorize and direct my executor to make necessary arrangements with FOC to transport my cat(s) to a site within San Diego County agreeable to FOC.
- 4. I will make FOC aware of any pre-existing medical condition(s) with my cat(s).
- 5. FOC provides the following for all cats in our custody:
  - Veterinary: an annual exam, vaccinations, medications, treatment/surgery as required.
  - Shelter: Attendant(s) on premises 24/7.
  - Shelter Care: Premium food, special diet when required, grooming, monthly in-house exam.
- 6. Adoptability of any cats in Lifetime Care, is based upon the owner's wishes. FOC will endeavor to find adoptive homes for any of my cats I wish to be adoptable in status. The adoption agreement shall provide that my cat(s) may be returned to FOC if the adoption is not successful. The relinquishment fee for Cats under 8 years of age and relinquished as "adoptable" will be a minimum of \$400 per cat.
- 7. Lifetime Care (LTC) ~ fee is \$5,000 per cat. The following constitutes LTC.
  - 1. Cats 8 years of age or older
  - 2. Cats under 8 years of age that the Relinquisher does not want to be adopted
  - 3. Cats of any age with medical issues (FIV, FeLV, Diabetes, other medical issues)
  - 4. Cats that are feral

	8. The LTC fee does not reflect the actual costs required for maintenance of your cat(s). Any funds received in excess of the fee enables FOC to provide care and homes for less fortunate cats.
